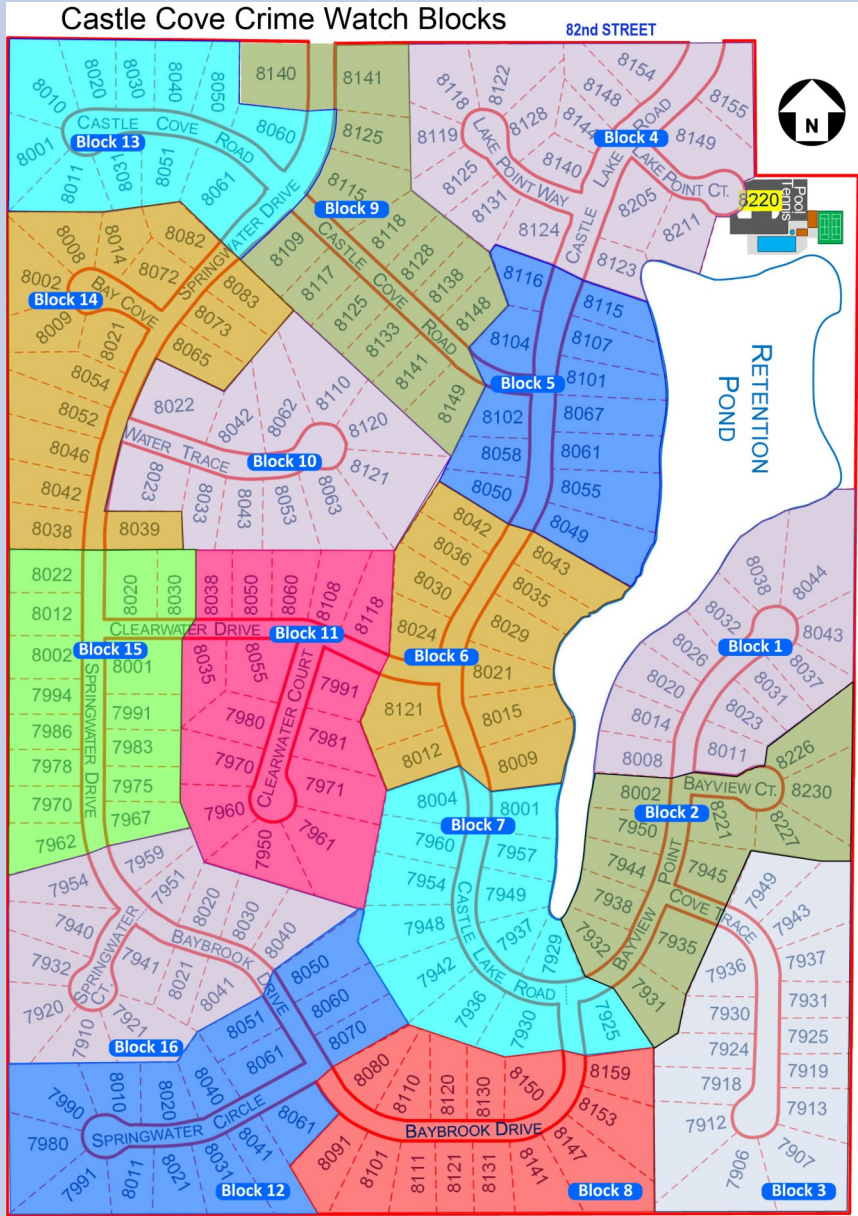

## Block Captains' Responsibilities

- Introduce Crime Watch program to block residents.
- Get to know neighbors and encourage opportunities for neighbors to better acquaint themselves with each other.
- Share helpful crime prevention tips.
- Serve as an information liaison between residents, block captains and the neighborhood coordinator.
- Receive and share facts about criminal and/or suspicious activity.
- Maintain a directory of residents' current contact information.
- Share contact information with neighborhood coordinator.
- Participate in quarterly planning meetings.

## Residents' Responsibilities

- Get acquainted with neighbors.
- Implement crime prevention techniques.
- Call law enforcement immediately when crime or suspicious activity is noticed.
- Report suspicious license numbers to law enforcement.
- Report observed incidents to block captain after law enforcement has been notified.
- Attend block and neighborhood social gatherings regularly.
