Meeting minutes from May 11 were approved.

#### Treasurer Report Approved – Tom Stephenson

Bank balances as of June 30, 2010:

Checking \$13,904.46 Savings \$49,701.96 Reserve Fund \$47,140.15 TOTAL \$110,746.57

It is projected that there will be approximately \$28,000 left at the end of the year after expenses but not including the reserve fund.

#### Committee Reports

Architectural control – Frank Borelli

No requests since last meeting

#### Auditing –

Linda Dernier and Audrey Neucks will review financial records before next board meeting.

#### Common Grounds – Marie Wright

We will have a combination of annuals and perennials planted at the entrances. The No Soliciting signs will be moved closer to the entrances.

The shelter house has been used more often this summer.

Electrical work on the shelter and pool houses has been completed.

#### Compliance Committee –Lana Jordan

The committee has received several complaints of boat parking. Owners have been notified and have moved the vehicles.

Several complaints have been received about vicious dogs in the neighborhood. Neighbors should call the police if assistance is needed.

There was discussion about residents using the common grounds (pool, tennis courts) without having paid their dues. It was decided to send letters to those residents who have not paid their dues in full to remind them they are not eligible to use the pool and other neighborhood facilities.

#### Crime Watch – Jay Bobian

Most complaints are about dogs in the neighborhood. For dog bites, the resident should call the police.

The IMPD Crime Watch coordinator encourages us to lock the gate at the pool parking lot each night in an effort to curtail unknown vehicles and suspicious activity in that area. We will need to paint and repair our gates and will lock them for the winter. Greg Bond offered to help with paint selection and Larry Jordan offered to do the painting. The bike rack will also be repaired and painted.

The National Night Out and Ice Cream Social will be held on August 3 from 6:30pm to 8:30pm at the pool.

#### Nominating – Jay Bobian

Talking to neighbors about serving on the board. Marie Wright, Audrey Neucks, and Lana Jordan's board positions will expire at the end of the year.

#### Pool – Tim Scofield (absent)

Ruth Ann Stephenson and Marie Wright presented information about other neighborhoods' pool access methods. Some have card readers, key pads, or laminated cards held by the lifeguard. Some had no rules on guests, others charged \$1-2 per guest, and others had a limit on the number of guests allowed. Access control will help in

controlling use of the pool and tennis courts only to residents who have paid their dues and also allow people to use the restrooms when the pool area is closed. Further information will be obtained to aid in making a decision as to the best method for Castle Cove.

#### Tennis – Larry Jordan

Pickle ball lines have been placed on the east tennis court in dark blue. The committee stated that the lines do not interfere with tennis play. Larry wants to paint the lines in the official width for further evaluation by tennis players.

The committee submitted proposals for a new court to be reviewed by the Board.

A plan for the tennis courts will be submitted at the annual meeting for residents to review.

#### Web Site – Ruth Ann Stephenson

Ron Sans has been updating the current website. Information will continue to be provided through this website instead of paying a web hosting fee for a neighborhood website. The goal is to provide residents with helpful neighborhood information all in one location. The link is published in each newsletter.

#### Welcome – Marie Wright

Three families have been welcomed to the neighborhood with a packet. One new family needs to be welcomed.

#### Old Business

Tiplick Project – no news to report. Trial is scheduled for September 13. Charges will be dropped if project is completed prior to the trial.

Speeding – Discussion of adding "Slow" signs to the crime watch posts. DPW has been contacted about this request.

Weeds on streets and curbs – some people take care of weeds in the street in front of their houses. The board is considering hiring someone to kill the weeds in the streets and curbs and will get estimates to do so.

#### **New Business**

Pool leak – Water under the pool deck is not a leak from the pool. It had a chlorine content, but not during every test. The company that evaluated the leak said that it's not a leak, but surface water runoff from the pool or slowly evaporating rain water. This drainage issue will be repaired with the tennis court project.

Pool closing time on July 4 – Discussed pool hours for the holiday. Will postpone discussion until Tim Scofield can attend.

Mail/PO Box – Tom Stephenson would like to stop using and paying for the PO Box and use a locked mailbox at the pool house. Discussion tabled because of the risk associated with an exposed mailbox.

Money Market Account – per the covenants, Tom Stephenson is creating a reserve account to retain money for capital improvements. Discussion tabled until the next meeting due to late meeting time.

#### **Two Special Board Meetings Held**

The Castle Cove Board held Special Meetings on June 15 and June 29 to discuss the condition of the tennis courts, proposals for their repair and replacement, and the addition of other amenities to the common area. During these discussion and brainstorming sessions, current use of the courts was evaluated and neighborhood resident expectations were considered. The budget to accomplish these improvements is a considerable amount. The Board is entrusted and empowered with governing the neighborhood to the best of their ability for the benefit of the residents, and they are working diligently to perform to those expectations. More information will be forthcoming this year and this project will be an agenda item at the Annual Meeting in November.

### Common Area Revitalization

Last year, the Board budgeted \$7,000 to resurface the two tennis courts which have numerous huge cracks. The Tennis Committee reviewed three bids and because of age and terrible condition of the courts, no contractor would guarantee their work for more than 1 year. Two of the bidders recommended total replacement.

Returning the tennis courts to good playing condition is the original challenge presented to this committee. In their efforts to solve this problem, the committee saw an opportunity to improve other amenities and provide a variety of recreational activities so more residents can enjoy the area.

Some of the additional ideas included:

- New tennis court (s)
- Picnic tables and a charcoal grill along the lake
- · A deck beside the lake to sit and fish.
- Improvements to the shelter house.
- A more sophisticated access system for the pool, tennis courts and restrooms (card reader, keypad, etc.). This would limit use to only those residents who have paid their dues as well as allow access to the restrooms and tennis courts at times when the pool is not open.
- A half court basketball court
- A sand or grass volleyball court
- Capping off the top of the hill north of the tennis courts for a recreational activity
- An area for horseshoes and corn-hole toss
- A small fenced in area accessed off the swimming pool for small children who would like to run around and play rather than swim.

The Revitalization Committee developed a preliminary, multi-year plan, met with contractors, solicited bids and presented their findings to the Board. Numerous meetings have been held reviewing current use, priorities, needs and wants, current bids, budget and variations of the plans. As with most projects, the driving force is the cost and amount of money available for the project. The Committee is currently working with the Board on perfecting these plans and information will be shared with the General Membership at the Annual Meeting in November.

Castle Cove has such a beautiful location for our common area and we need to maintain our amenities in a manner which not only provides safe, well-kept facilities for our residents, but ensures our community is a desirable place to live and reflects in a positive manner on our property values. The Castle Cove Board has been elected by the residents and authorized by the Covenants to preside over the neighborhood for the benefit of the residents to maintain, repair and replace the improvements on the common property as necessary using a portion of the Annual dues for this purpose.

More information will be forthcoming in the next newsletter and will be presented to the General Membership for discussion at the Annual meeting in November.



## Pickle-ball Comes to Castle Cove



My name is Maury Lathrop, a 21-year resident of Castle Cove living on Water Trace. Recently, I was given permission to line the East tennis court for pickle-ball.

Pickle-ball is a game similar to racket ball and tennis, using a smaller court (44'x 20') and the existing tennis net. A paddle similar to an enlarged ping-pong paddle and a hard whiffle-type ball are used for play. Four (4) players, two on each side of the net play the game. The rules are simple to learn and actual play is encouraged to learn the game. Pickle-ball has become very popular with seniors and anyone else who tries it. Many high school students are introduced to the game in gym class. Paddles and balls will be provided for anyone interested in learning the game.

US Representative Joel Pritchard of Seattle invented pickle-ball in 1965. The name was chosen because "Pickles" (Pritchard's dog) liked to run off with loose balls, inspiring the name for the new game.

Saturday, June 19, several players met at the court for the first time and we played for approximately 3 hours. Any adult resident between the ages of 16 and above who would like to learn pickle-ball is encouraged to attend on a Saturday morning to get some exercise, have some fun, and meet some of your neighbors.

We meet every Saturday at approximately 7:30-8:00 AM — weather permitting — and play continues for 2-3 hours.

I would also like to organize a time for the children of Castle Cove (ages 10-15) to learn the game as well. Please contact me for more information.

#### WHAT SHOULD YOU DO?

In June, one of our Castle Cove residents, Alice Herrin, who lives at 8021 Castle Lake Road was faced with the dilemma of what to do with a dead animal floating on the lake behind her home. The animal became lodged and began to get very swollen and repulsive — to say the least!

She initially called the Mayor's Action Center and Dead Animal Control only to learn they are not allowed to pick up dead animals on private property. Their duties are restricted to public property including roads.

She did learn that the **Health Department** is who would help her. She called them at 221-2150 and they cheerfully came and removed the animal which turned out to be a possum!

Thanks Alice for sharing this story and good advice to neighborhood residents.

# Would you want all this trash left in your front yard?



Well, it was! Oh, you didn't see it? As a resident of Castle Cove, everyone is a co-owner of the common area including the parking lot, pool, tennis courts, playground and common area. This pile of trash was picked up one recent morning from only the parking lot and surrounding sidewalk and grass West of the pool plus 3 water bottles just inside the tennis courts. As you can see, it includes 2 fast food bags and contents (squishy ketchup & leftovers, etc.), many drink containers, worm cartons, wrappers and even broken glass. There is a trash can outside the fenced areas by the restrooms.

Please, please dispose of your trash properly. Otherwise, your dues may have to include paying someone to pick up your trash!





### Man's Best Friend ??

Many people, including residents of Castle Cove, are dog owners and dog lovers

and there are some wonderful dogs in Castle Cove.

Dog owners may totally trust their dog and his/her behavior, but in a different or unusual situation, a dog may not always behave as expected. Therefore, there are City ordinances to protect residents from those unexpected dog behaviors. And, there are those people who have had bad experiences with dogs or are just plain afraid of all dogs.

#### Did you know?

- All dogs have the potential to bite
- Dog bite incidents are to be reported to the police
- The law requires you to "contain" your dog within your own property. Municipal Code Section 531-102 states that owners can be fined between \$100—\$500 depending on the situation.
- Dogs must be on leashes when not on your property. This means dogs are not permitted to "run loose" even when playing with their owners off of their property. This is the law, not just a Castle Cove "rule".
- All dog owners are responsible for the actions of their dog.

Several infractions of the above laws involving dogs belonging to Castle Cove residents have occurred recently. A dog may become aggressive due to various reasons including dominance, fear, or being protective. Castle Cove residents who run, walk and ride their bikes in the neighborhood and enjoy the common grounds regularly are more frequently encountering loose dogs that appear to possibly be aggressive. Barking dogs that disturb the peace are also infractions of the law.

PLEASE CONTACT IMPD REGARDING NUISANCE DOGS. Castle Cove Board members, although sympathetic to these issues, have no jurisdiction in these matters and IMPD should be called at 911 or 327-3811.



# Compliance Committee

Fellow Castle Cove Residents.

Have you noticed that many Castle homeowners have been doing a great deal of painting, trimming and other things to maintain and improve the investment in their homes? Many of you may be feeling it is a never-ending job ---- and it is. The payoffs, however, are tremendous, including a well-maintained home, pride in your home and neighborhood AND Castle Cove's appeal to those who may be house shopping. We often hear the resident realtors affirm that Castle Cove remains a highly desirable neighborhood. We all need to do our best to keep it that way. Routine maintenance can usually prevent a more expensive repair when you wait too long.

Getting a call from me as Compliance Committee Chair has been a surprise to some residents and somewhat expected by others. I must say that, as this Committee's chair, Board Member and neighborhood resident, I've been pleased with the willing responses to requests for compliance with the Covenants and standards of our neighborhood. That makes my assignment much less difficult and easier to reach our compliance goals.

#### However, there is still much to be done:

- Mailbox and post painting replacement
- Painting and/or repair of garages, homes, storage sheds
- Repair or replacement of garage doors
- Proper weed control and grass mowing
- Removal of yard refuse (trimmings, branches, trees, etc.)
- Removal of trash (including discarded basketball goals and other large items)
- Cutting down and removal of dead trees
- Trimming of tree branches overhanging sidewalks and streets
- Proper containment and timing for trash pickup. Trash is to be contained out of sight and placed curbside for pick up Sunday evenings with trash containers being put away by Monday evening at the latest.

As was announced at last year's annual meeting and subsequently communicated in our newsletters. I will continue to make initial contact via phone about issues to correct. Then, if warranted, a written reminder will follow.






